STIPULATION AND ORDER FOR EXTENSION OF PAGE LIMITS

WHEREAS, on June 11, 2009, Intel Corporation and Intel Kabushiki Kaisha (jointly, “Intel”) filed a Request for In Camera Review of Disputed Document (MDL No. 1717-JJF, D.I. No. 1892; C.A. No. 05-441-JJF, D.I. No. 1545) (the “In Camera Review Request”);

WHEREAS, on June 12, 2009, Intel filed a Motion to Compel Glover Park Subpoena (MDL No. 1717-JJF, D.I. No. 1901; C.A. 05-441-JJF, D.I. No. 1552) (the “Motion to Compel”);

WHEREAS, Plaintiffs Advanced Micro Devices, Inc., and AMD International Sales and Service, Ltd’s (jointly, “AMD”) requested, and Intel did not oppose, an extension of the page limits for AMD’s responses to the In Camera Review Request and Motion to Compel;

IT IS HEREBY STIPULATED AND AGREED, by and between the parties hereto, subject to the approval of the Court, that AMD shall file a response to the In Camera Review Request not to exceed 8 pages, and a response to the Motion to Compel not to exceed 6 pages.

IT IS FURTHER STIPULATED AND AGREED, that Intel may request, and AMD will not oppose, a reasonable extension for its replies to AMD's responses.
