## The Intel<sup>®</sup> Server Board S1200V3RPS may not recognize PCIe devices in slot 4 during POST

### Products Affected

Intel<sup>®</sup> Server Board S1200V3RPS  
MM#: 927057

### Description

Intel has discovered that the server products listed above may not recognize devices in slot 4 during POST, and the "missing" PCIe devices may be recognized after the next power cycle. This issue is found to occur only in PCIe slot 4 and the issue has not been replicated in any other PCIe slot.

### Root Cause

Intel is investigating the root cause.

### Corrective Action / Resolution

Intel will continue to investigate the issue and provide timely updates.

### Workarounds

Intel recommends to NOT install PCIe devices in PCIe slot 4.
